- 3. ALL BOWLERS / TEAMS WILL BE ASSIGNED THEIR STARTING LANE.
- 4. EACH BOWLER WILL BOWL SIX (6) GAMES IN QUALIFYING. ONE LANE / APPROACH COURTESY WILL BE USED IN QUALIFYING. THE TOTAL OF THE TEAMS TWELVE (12) GAMES WILL DETERMINE FINISHING POSITION IN QUALIFYING.
- 5. TEAMS WILL CHANGE LANES AFTER EACH QUALIFYING GAME.
- 6. THE TOP FIVE (5) TOTALS FROM QUALIFYING WILL BOWL A BAKER DOUBLES STEPLADDER FINALS. THE FIFTH(5th), FOURTH(4th) & THIRD(3rd) PLACE QUALIFYING TEAMS WILL BOWL ONE(1) GAME WITH THE WINNER ADVANCING TO BOWL THE 2nd PLACE QUALIFYING TEAM. THE WINNER OF THE SEMI-FINAL MATCH WILL BOWL THE TOP QUALIFYING TEAM FOR THE CHAMPIONSHIP.
